

STICK WITH THE CSRT

Alicia Salvatore R.T.(R) CSRT President 2021-22

A fter a quick google search on 'how to start something new and stick to it', the article that stood out most to me was titled "Ten Reasons Why We Don't Stick to Things". I would like to talk about three of them in relation to my time with the CSRT.

The first, 'We run from discomfort or uncertainty.' Now, I am not going to lie. If you know me, you know this is true. I used to not be able to make phone calls because I did not know who would pick up or what they would say when they picked up. It took me years to finally be able to make phone calls on my own. Just like making phone calls, I avoided new things; including the CSRT. However, when a few of my classmates who I knew well said we should all volunteer together at the CSRT Annual Conference in 2016, I said yes because my classmates gave me familiar faces I could turn to if needed. The funny thing is, throughout the conference, I talked to many of the CSRT board of directors and volunteers and not once did it feel like I had not already known them. They were all so welcoming and eager to share their knowledge and experiences with me. Because of that easy, comfortable feeling, I kept saying yes to volunteer opportunities with the CSRT. I said yes to volunteering with the student committee with some of my classmates. I said yes to making flyers for events. I said yes to emailing (not calling) companies asking them to sponsor the annual conference. I said yes to being Conference Committee Chair and planning an entire conference! I said yes to being Secretary, President-Elect, President and now, I am saying yes to volunteering once again as Chair of the Board and I could not be happier about that. Discomfort/uncertainty seems like something of the past for me. The CSRT has helped me to open up to new opportunities knowing that there is always someone who has done it before and if not, the whole group will figure it out together!

he second reason we don't stick to things, 'We forget why it's important.' Now, I have L been volunteering with the CSRT since 2016. Most of what we have done is provide regular CEU lectures, annual conferences, networking activities, College Bowl competitions and job fairs. Our membership is our priority and I think we have shown that well. It did not really hit me how important The CSRT is to not only our membership but to our profession until I was contacted first by a Physical Therapist in February and second by an Advanced Practice Registered Nurse in May. Both contacted us to discuss potential changes to their practice standards which could in turn affect our profession. Physical Therapists (DPT) in Connecticut are unable to order xrays. They would have to refer their patient to an M.D. and have that doctor order the xrays. Thus, the patient is being billed for an additional provider visit when the Physical Therapist was able to identify an issue and recognize the need for imaging. Their goal is to be allowed to order xrays to eliminate that extra appointment with a healthcare provider and in turn, speed up diagnosis and treatment. They recognize and accept that image interpretation is beyond their scope of practice and only intend to order the imaging, not interpret it. The CSRT Board of Directors agreed that this could be beneficial for patients and would not infringe on our profession.



The APRN's however were looking to propose a change to their practice standards that would infringe on our profession. The APRN's wanted to gain the ability to perform diagnostic and therapeutic fluoroscopic exams to streamline care. The CSRT cited a lack of radiologic science and radiation safety education and lack of physician oversight for APRN's for our disapproval of this proposed change. The CSRT recommended the APRN's approach the radiologists and see what their sentiment was as well as keep us updated on any new insights. While both of these meetings were more for the PT and APRN societies to understand our position and learn why we would be for or against their proposed changes, The CSRT does pay for a lobbyist to keep a watchful eye legislatively for any new proposed Scope of Practice changes or bills that will affect our profession and they have been instructed to pay close attention to these areas.





The last reason why we don't stick to things, 'There are too many barriers.' The CSRT has heard a version of this time and again. "I don't know how to contact you", "I don't know what I would volunteer for", "I volunteered but no one got back to me with a task". We sincerely hope this is not the case for our members that want to get involved and stay involved now. If it is, here are a few ways I would like to try to help mediate that. A SUMMARY OF THE ASRT HOUSE OF DELEGATES

A recap of Alicia Salvatore and Ryan Appold's experience at the ASRT House of Delegates and Annual Governance Meeting in Orlando, FL as Connecticut delegates.

rom June 24th - 26th, 94 affiliate delegates and 58 chapter delegates along with almost 90 Student to Leadership Development Program participants and ASRT members met at the 2022 ASRT Annual Governance & House of Delegates Meeting in Orlando, FL.

risti Moore, Ph.D., R.T.(R)(CT), 2021-2022 ASRT President gave the ASRT annual report in which she outlined that there are greater than 345,000 technologists worldwide and the ASRT has a membership that is almost half that number! She stated the ASRT's continued advocacy efforts to fight encroachment and promote the passage of the MARCA bill for its 156,000 members. Dr. Moore touched upon her three presidential initiatives, giving inspiring updates on each. Her first initiative was to build a professional section of the ASRT website. This was successfully accomplished with the launch of the Building Professionals section for the Radiologic Technology and Radiation Therapist journals, which will feature columns written by students. Her second initiative was building a resource for those looking to become educators with the successful launch of the ASRT Faculty Roadmap on the ASRT website. Dr. Moore's last initiative was to create a pathway for individuals to encourage diversity and inclusion in the ASRT and the medical imaging and radiation therapy communities and encourage a safe and open environment all aspects of the profession across through the ASRT Diversity Leadership Development Program. Dr. Moore, ended

with her favorite quote, "Teamwork makes the dream work", which I fully believe in.

he Committee on Bylaws Report Main Motion B-22.01 to amend Article V. House of Delegates; Section 3. Delegate Requirements and Qualifications; A. Affiliate Delegates; 6 which, as proposed read: 'A delegate shall practice or be eligible to practice in the medical imaging and radiation therapy profession health care by maintaining registration or certification in a primary modality by certification agencies recognized by the ASRT or by holding an unrestricted license in medical imaging or radiation therapy under state statute.' The rationale for the update was for affiliates to have greater flexibility in selecting their delegates. The Bylaws Open Forum incited much debate. Some of the debate surrounded the idea that someone not working in healthcare could be representing an affiliate. The rest of the debate surrounded the newfound ability for retirees to represent an affiliate as a delegate as long as they maintain their credentials should this amendment be adopted. It would allow for a larger pool from which to select delegates from and this could potentially help delegates struggling to seat delegates. The proposed amendment was not adopted with a vote of 82 against adoption to 65 for adoption.

he CSRT did vote for the adoption of B-22.01. The ASRT was asked to obtain data with which to base the change on that the Bylaws Committee could review prior to the 2023 HOD meeting.

uring the Commission Hearing, there was much discussion about what remote CT scan meant and how it impacted the profession. A few delegates gave testimony about the workings of rural hospitals with few staff and little knowledge of advanced scan techniques which would be served by having a technologist remotely access their unit while an on-site RT would tend to the patient.

he Commission Report Main Motion C-22.01 to amend the Practice Standards document was adopted. Proposed Amendment #1 was adopted and proposed amendment #2 was also adopted. No late main motions were presented to the House.

onnecticut's very own Daniel DeMaio, M.Ed., R.T.(R)(CT) was unanimously elected Speaker of the House. Dan's goals for the future include increasing membership and involvement, especially in our newer/younger members. In addition, he hopes to change the way the ASRT asks for volunteers in the hopes of attracting new minds with fresh perspectives.

The ASRT Update was given by Sal Martino, Ed.D., R.T.(R), FASRT, CAE, CEO of the ASRT. Dr. Martino mentioned that the Covid-19 webpage was highly successful and is still one of the most used pages on the ASRT website. The Covid-19 Emergency Relief Fund received allocations of \$150,000 from the ASRT Foundation and \$100,000 from the ASRT. In total, over \$300,000 has been distributed since 2020. Dr. Martino also updated the delegates on the move from having the directed readings in the journals to having them available in the CE Library on the ASRT Website, with an opt-in option to have a CE supplement in print mailed to you. Across multiple social media accounts and platforms, the ASRT has more than 180,000 followers.

ast, Dr. Martino spoke about the importance of the passage of the MARCA bill for the Radiologist Assistants. RA is a pathway for all RT's as an advanced level practitioner but with no medicare reimbursement, the pathway. could fizzle out. We need to do as much as we can to ensure the future of this pathway.

Radiation Therapy & Dosimetry Chapter Meeting:

were discussed. Main Motion B-22.01 which, if adopted, would allow retirees that have maintained their credentials to represent affiliates as delegates. Agreement was reached that the motion would be good for affiliates but not for chapters as the representative should be currently practicing in the modality they are representing.

osimetry chapter is on probation for not seating the minimum amount of delegates. Dosimetry chapter and the ASRT have lost many dosimetry members to the AAMD. Many feel that dosimetry is not well enough represented and is not in focus in the ASRT while it is in the AAMD.

he Radiation Therapy chapter discussed the ARRT cut-score change from 2019 and how it has impacted student scores and pass rates. The new 2022 ARRT didactic requirements are now to be used. Dermatology clinics needing R.T.(T)'s to treat skin cancers were also discussed. In California, a Dermatologist must have a supervising xray license - Title 17 to be the supervising M.D. for those procedures instead of a Radiation Oncologist. According to the Therapist practice standards, therapists work under a radiation oncologist while SRT would have therapists reporting to a dermatologist. Of note, many dermatology offices only have a P.A. on site while the supervising M.D. is off-site at a central location.

he Radiation Therapist journal removing the directed readings is good as it leads one step closer to having the journal included in scholarly databases.

Radiation Oncology Safety Stakeholders Initiative may disband. They had been meeting to discuss safety in the radiation therapy and oncology profession and had actively sought input from radiation therapists and dosimetrists. The question now is how do we maintain a seat at the table with these larger, radiation oncology based groups? First thought is to get a seat with the AAPM. If we as therapists are using the machines approved by the physicists, we should also be collaborating with them.

Radiologist Assistant Chapter Meeting:

ARCA or the Medicare Access to Radiology Care Act H.R. 3657 & S.2641, L dominated much of the discussion for this meeting. It was discussed how although it received bipartisan support it wasn't passed through standard means. There is hope that it will be part of an Omnibus Bill which would lead to its adoption. Attendees were reminded to contact their representatives and senators to gain support for this bill. It was emphasized how MARCA is essential to the future existence of Registered Radiology Assistants(RA's). Dr. Paul Larson of ARRT, said at a recent meeting of the American College of Radiologists (ACR) that they adopted a Neutral Stance on MARCA which was a little bit of a disappointment since there were no objections to it at all. He said at next year's meeting of the ACR that there is a chance that they may change their stance to be In Support of MARCA. One of the big messages relayed to attendees of this chapter meeting was that in no way are RA's meant to replace PA's and that the biggest encroachment to RA's is from Advanced Practitioner Registered Nurses (APRN's). To close the meeting, various educational programs that offered certification for RA's were highlighted; programs included: Quinnipiac University, Weber State, and University of North Carolina.

Education Chapter Meeting:

A Bill ABI273 - Earn & Learn passed in October 2021. Feel that this earn & learn structure is antiquated and is not practical for this profession. JRCERT does not allow Earn & Learn and schools would lose accreditation if they do allow it. 131088B is a position statement against Earn & Learn.

iscussion to add a certification exam for educators. The certified RN educator exam would be used as the basis. Agreed that it would be great to have standards to aspire to but much needs to be done to outline what those standards would be and how they would be achieved. The goal is to make teaching a recognized practice within the Radiologic Science community.

Radiography Chapter Meeting:

Shielding was a huge topic of discussion. Although the ASRT did release their position statement regarding gonadal shielding, there still seems to be some confusion in hospitals. It was emphasized that per the ASRT's position statement, only during abdominal and pelvic exams should shielding be discontinued. Sadly it seems many hospitals have moved away from shielding entirely.

uring the meeting students and educators alike spoke on how shielding varied from facility to facility. A student spoke about how her educational program required shielding on competencies, but clinical sites would fail her for shielding if the clinical site no longer shielded patients.

Computed Tomography Chapter Meeting:

ruch of the discussion during the meeting was related to the addition of remote CT scanning in the ASRT Practice Standards document. The proposed changes stood to promote the presence of a registered technologist in the room physically present with the patient even though an additional registered technologist is performing the scan remotely from a different location. The rest of the discussion was on mandating CT certification and how it might limit the amount of technologists available to perform scans which might in turn limit life-saving care. Even though medicare/medicaid reimbursement is based on the percentage of certified technologists at a facility, critical access hospitals are exempt.





There continues to be confusion about the recommended elimination of fetal and gonadal shielding during abdominopelvic radiography and inconsistency on how this change in practice is being implemented. In response, the ASRT has convened a Patient Shielding Task Force, with a purpose to develop and disseminate educational materials for both practitioners and for patients. It's important for those we serve to know that RTs are experts in radiation protection and use a wide array of techniques and technology to reduce patient dose, including shielding, when appropriate. WHO CAN IRRADIATE IN THE STATE?

The CSRT helps to protect your rights & privileges as an R.T.

ears of study, documentation clinical competence the successful completion certification exams have earned you the credentials of R.T.(R) with the privilege to competently and safely apply your skills to patients. You should be informed on how to keep that privilege from those who have NOT earned it. Our clearly defined state's practice standards can be located under ct.gov "Chapter 376(c)". Only R.T.'s that hold the proper ARRT credential and Connecticut State license may operate radiographic equipment, specifically: "energizing the beam, positioning the patient, and positioning or moving any equipment in relation to the patient."

few exceptions allow certain professionals to utilize ionizing radiation for diagnostic purposes:

Physicians' Assistants (PA) - may perform only fluoroscopic procedures after ARRT certification in fluoroscopy.

Radiologist Assistants (RA) - may perform many fluoroscopic procedures under the direct supervision of MD's.

ther medical professionals performing radiologic or fluoroscopic procedures outside of these guidelines are inviolation of statelaw.


