### Purpose:

The purpose of this award is to recognize the advancement of radiologic technologists who have demonstrated superior leadership, advocacy, educational promotion or other achievements.

### Award:

The award includes:

Monetary award of \$400 or by the discretion of the CSRT BOD

### Eligibility:

- Current active state of Connecticut Licensure or National Certification for medical imaging modalities
- Current CSRT member with a minimum of 2 consecutive years of active membership.
- Previous winners of the award are NOT eligible for reapplication for two years.
- Current CSRT board officers are NOT eligible to apply

### Application Requirements:

- Documentation of active CSRT Technologist level membership.
- Documentation of active Connecticut Licensure or National Certification showing your modality.
- One letter of recommendation: Must be from a credentialed R.T. or from a related professional (Radiologist, Educator, RA, Program Director, etc).
- Completion of one of the Options below.

## Technologist Achievement Recognition Award Application

Choose one of the submission options below and complete the requirements for that option. Both options are judged equally.

#### Option 1

Please answer the following questions in 200 words or more per question

1. Introduce yourself. What aspects of medical imaging or radiation therapy engaged you to pursue a career in the field of Medical Imaging or Radiation Therapy? What are your career goals within the field?
2. Describe your contributions and role with community service, volunteer experience or advocacy. Please list volunteer experience from the last five years only.
3. List at least 1-2 examples of personal leadership abilities and then explain how those leadership abilities have been applied. How will those leadership abilities help you with your career goals?
4. What are some topics that interest you regarding the profession of Radiologic Technology? I.e. shielding or new technologies, etc.
5. What are some action steps you can take to further the profession of Radiologic Technology? I.e. promote occupational licensure, fight encroachment, etc.
6. What is the importance of knowing your technical factors and how do you apply them in your practice? **OR** With the increasing use in technology in the radiation therapy department, what is the biggest challenge when treating a patient? If you were able to change it, what would you do to modify and improve the process to increase patient safety?

#### Option 2

Submit a presentation in powerpoint format with an abstract of approximately 150 words on a topic pertaining to radiologic technology or radiation therapy that could be presented for 0.5 CEU credits (30-45 minutes). AMA style citations in powerpoint should be included.

Your willingness and ability to educate other Radiologic Technology professionals about the topic of your choice for continuing education may be used for a future CSRT event.

\*PPT does not need to be CEU approved for submission.
